1. Photos and videos may be taken from the spectator seating and walkways in the show arenas, in warm-up pens and around the grounds. Photography or videography from the arena floor, cattle pens or any other area that may obstruct gates or access points during competition is strictly prohibited.
2. Media will respect exhibitors and refrain from disturbing or disrupting them as they are preparing to show.
3. Media will act professionally at all times and respect any instructions given by CRCA staff. Failure to do so will result in ejection from the event and/or denial of future requests for media credentials.
4. During competition media will not be permitted inside the show arena, cattle pens or any other area that may obstruct gates or access points.

Violation of the CRCA Media Policy may result in immediate removal from the event premises, refusal of future media credential requests, and/or an indefinite ban from CRCA events.

Colorado Reined Cow Horse Association members/exhibitors who violate the CRCA Media Policy may face disciplinary action including, but not limited to, suspension, fine and ban from competing at future CRCA events.
